**Preamble:**

Manjeera College of Education, Sy.No.11/3, Shahapur Gate, Gunali Taluk, Bidar – 585401, Karnataka submitted application to SRC on 31.10.2008. The application was considered for the session 2009-2010 after conducting inspection and other procedures. SRC in its 178<sup>th</sup> Meeting held on 29-30 July 2009 decided to refuse recognition. Accordingly, order of refusal was issued to the institution vide order dated 30.07.2009.

The institution preferred appeal Under Section 18 of NCTE Act, before the Appellate Authority, NCTE, New Delhi against the rejection order of SRC. The Appellate Authority vide order dated 26.11.2009 remands back the case to SRC for causing inspection on payment of Rs.40,000/- towards inspection fee.

The matter was placed before SRC in its 185<sup>th</sup> meeting held on 26-27 November 2009 and SRC decided to cause re-inspection on payment of Rs.40,000/- and call for necessary document. Accordingly, a letter was issued to the institution on 05.01.2010. The institution has submitted Demand Draft bearing No.018139 dt.22.01.2010 for Rs.40,000/- towards re-inspection fee along with relevant documents.

Re-inspection to the institution has been carried out on 15.02.2010. The re-inspection report was placed before SRC in its 189<sup>th</sup> meeting held on 25-26 February 2010 and decided to issue Letter of Intent. Accordingly, LOI was issued to the institution on 01.03.2010. The institution submitted its reply on 29.03.2010. SRC in its 190<sup>th</sup> meeting held on 29-30 March 2010 considered the reply and decided to issue notice. Notice was issued to the institution on 31.03.2010. The institution submitted its reply on 15.04.2010. SRC in its 191<sup>st</sup> meeting held on 20-21 May 2010 considered the reply and decided to issue to issue formal recognition order.

Hence the order.

**ORDER**

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Khan Education Society, Badruddin Colony, Hanuman Nagar, Chidri Road, Bidar – 585403, Karnataka has submitted an application to the Southern Regional Committee of NCTE for grant of recognition for conducting B.Ed course with an intake of 100 students on 31.10.2008.

2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, institution fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the B.Ed teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has appointed duly qualified teaching staff as per NCTE norms.
3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to **Manjeera College of Education, Sy.No.11/3, Shahapur Gate, Gunali Taluk, Bidar - 585401, Karnataka** for conducting B.Ed course of One year duration with an annual intake of **100 (One hundred)** students from the academic session **2010-2011** under clause 7(11) of NCTE(Recognition Norms & Procedure) Regulations, 2007 subject of fulfillment of the following conditions:
  - I. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
  - II. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE( Recognition Norms & Procedure) Regulations,2007.
  - III. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.
5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
6. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
  - (i) Copy of the Application Form
  - (ii) Land and Building Particulars
  - (iii) Staff Profile
  - (iv) Recognition letter
  - (v) Information for having fulfilled the norms & standard and other required conditions.
7. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
